Code of Conduct

I, _____ (full legal name) of the _____ First Nation, agree to conduct myself in accordance with the terms of this Code of Conduct at all times while at the First Nations Leading the Way 7 conference on November 26 – 28, 2024 in Edmonton, Alberta (the “Conference”).

First Nations Leading the Way 7 (“FNLW7”) or the First Nations Financial Management Board (the “FMB”) may permanently remove me from the Conference at any time and upon its own discretion for failing to abide by the terms of this Code of Conduct.

I must conduct myself in accordance with the terms of this Code of Conduct at all times while at the Conference which includes, but is not limited to:

- a. In transit to the Conference;
- b. While attending any event or function during the Conference;
- c. While at a hotel or accommodation during the Conference; and
- d. In transit from the Conference.

I agree that I will adhere to the following principles and responsibilities governing my professional and ethical conduct to the best of my ability while at the Conference;

- a. I will conduct myself in a reasonable, respectful, considerate and lawful manner;
- b. I will not act, speak or otherwise communicate in a manner that is offensive, obscene or that reasonable persons may consider to be offensive or obscene;
- c. I will be respectful towards speakers and others expressing their opinions and refrain from causing a nuisance, interruption or disturbance of program content;
- d. I will comply promptly with FNLW7’s and FMB’s reasonable and lawful directions and those of the authorized staff, its contractors and of the relevant venues;
- e. I will not place the safety and health of any person(s) at the Conference at risk;
- f. if legally authorized to consume alcohol, I will do so reasonably and responsibly;
- g. I will not bring drugs into the event venue or hotel of accommodation, or consume them while at the Conference;
- h. I will not cause personal injury to, or defame, any person or damage the property of any person;
- i. FNLW7 or FMB may without liability, eject me (and/or a relevant person) from the Conference and/or refuse entry to the Conference if it reasonably considers that me or a relevant person are in breach of these terms and conditions.
